

## **CONSENT TO THE PROCESSING OF PERSONAL DATA**

By clicking on the check box, I, as the person concerned, express my consent to the processing of my personal data in the scope of name, surname and e-mail address by RUNOLOGY s.r.o. with its registered office at Krajinská 37, 82104 Bratislava, Slovakia, ID 50404237, registered in the Commercial Register of the District Court Bratislava I, Division Sro, Insert number 112592/B (hereinafter referred to as "the RUNOLOGY company") as the operator, for the purpose of sending marketing communications concerning with general information about news (general newsletter), via e-mail. This consent is also considered as consent to the sending of advertising messages and e-mail messages. I give my consent until further notice.

At the same time, I note that according to the relevant legal regulations, only a person who has reached the age of 16 can independently express his consent to the processing of personal data, while in the case of not reaching this age, the consent of the legal representative of the given person is required. ### **Information obligation of the operator**

The legal basis for the processing of personal data is the above-mentioned consent to the processing of personal data in accordance with Article 6 para. 1 letter a) Regulations on the protection of natural persons in the processing of personal data and on the free movement of such data, which repeals Directive 95/46/EC (General Data Protection Regulation) (hereinafter referred to as the "GDPR Regulation").
